So many reports to collect, so many people to recruit, so many meetings to plan - it was a busy time indeed! But in doing all of that work, they all came together for two important purposes:

3. We support our young adults in campus ministry, along with other young adult opportunities, such as our upcoming young adult gathering in Puerto Rico this January. This is such an important part of life as they explore their faith and make it their own and we get to help nurture those conversations!

We are helping our first call pastors lean into their leadership and nurture their God-given gifts as they discover the joys and opportunities of their first call experiences. This includes helping them out financially as they seek to reduce their educational debt that they bring into that first call.

Finally, I want to thank you for electing me as your bishop. Thus far, I have felt the full support of this synod as I visit congregations from week to week. The days of the election itself, along with the installation in September, have both been two of the most meaningful and life changing experiences of my life and your support is a significant part of it I have fully enjoyed visiting each congregation and look forward to seeing yours over the course of my six year tenure. Yes, I realize it will take four years to get to them all, but the way the time has been flying, it won't be long!

Please know that your synod staff are here for you and want to accompany you on your journey of faith. We will continue to pray for us all in our lives together to make sure that our relationship with you is supported and upheld in prayer, in both the joys and struggles of ministry. We want our relationships to be intentional and strong so that you never feel isolated in this work. We are grateful for your partnership in the gospel!

### ANNUAL MEETING MINUTES

Sunday, February 25, 2024

The Annual Meeting of the congregation of First Lutheran Church, Barron, Wisconsin was called to order at 10:27 A.M. by President Andrew Harrington (hereinafter referred to as “Chair” or “the Chair”). Attendance of the meeting was taken. Pastor Ron Mathews announced that a quorum had been met by in person attendance.

- At 10:27 A.M., the procedures for the conduct of the meeting and how voting will take place were discussed.
  - At 10:28 A.M., Pastor Ron Mathews conducted the opening devotions for the meeting. An appreciation was given to Andrew at this time. Pastor Ron detailed the worship attendance and membership statistical reports.
  - At 10:36 A.M., the Chair called for any motions to amend or supplement the Annual Meeting agenda.
  - At 10:39 A.M., the Chair called for an approval of minutes from the 2023 Annual Meeting. A motion as made by Keith Kolpack, seconded by Dallas Sloan to approve the minutes. The motion carried.
  - At 10:40 A.M., the Chair introduced the Church Council.
  - At 10:41 AM., the Chair announced elections for various posts in the coming year, including one year and two year term Council members, the Cemetery Board members, the congregation’s Luther Park representative, the Trust Fund Committee and the Nominating Committee.
1. The election(s) for one year term and two year term Council members were conducted. Council members named by the Nominating Committee include: Andrew Harrington, Lynn Haugen, Kelly Hover, Dani Felber and Ruth Anderson. The Chair asked for any nominations from the floor. There were no new nominations. A motion was made by Allison Rick and seconded by Carsten Ellison to elect this slate to the Church Council. The motion carried
  2. The election(s) for the Cemetery Board were conducted. Members named by the Nominating Committee include: Arlyn Colby, Vern Hanson, Dave Hanson and Amanda Olson for the two year term. The Chair asked for any nominations from the floor. There were no new nominations. A motion was made by Mike Otto to elect the named slate of candidates to the Cemetery Board, which was seconded by Terri Lansin. The motion carried.
  3. The congregation next conducted election to serve a two year term as First Lutheran’s representative to Luther Park. The Nominating Committee named Rod Norby to a two year term. The Chair asked for any nominations from the floor. There were no new

nominations. Pamela Jacoby made the motion to elect the named candidate as the congregation's Luther Park representative, which was seconded by Mary Shearer. Motion carried.

4. Two (2) candidates were up for election for membership on the Trust Fund Committee. The Nominating Committee named Dallas Sloan and Sally Ellison to a three year term. The Chair asked for any nominations from the floor. There were no new nominations. A motion was made by Jan Kienbaum and seconded by Sue Olson to elect this slate to the Trust Fund Committee. The motion carried.
  5. Finally, two (2) members of the congregation were named and/or nominated to serve a one year term on the Nomination Committee: Judy Rassbach and Jean Wick. The Chair asked for any nominations from the floor. There were no new nominations. A motion was made by Pamela Jacoby and seconded by Carolyn Verhulst to elect the slate to the Nomination Committee. The motion carried.
- At 10:46 A.M., Dallas Sloan gave the Trust Fund 2022/2023 report. Dallas reviewed all investments and gifts to First Lutheran Church.
  - At 10:52 A.M., the Chair called upon Jason Erb, the congregation's Treasurer. The Treasurer reported on the 2023 financial year for the church. There was no further discussion. The Chair asked for a motion to approve the 2023 Treasurer's Report. Dallas Sloan made a motion to approve the 2023 Report, seconded by Jan Kienbaum. Motion carried.
  - Auditor's Report. None submitted.
  - At 11:02 A.M., Jason Erb outlined the proposed 2024 budget. There was no further discussion. The Chair asked for a motion to approve the proposed budget for the 2024 church year. Dallas Sloan made a motion to approve the 2024 Budget proposal, which was seconded by Carsten Ellison. The motion carried.

# Trust Fund Report 2023/2024

You will notice that the Trust Fund has increased by about \$145,000 over last year. The church received the final gift from the Ruth C. Anderson estate for \$66,985 last fall. What a tremendous gift to receive! Thanks be to God. This gift was put in the Perpetual Fund so the church will be able to see long-term benefits from this gift. As you will recall, the committee also has the ability to invest monies now—up to 50% in non-FDIC insured funds. Last year we earned \$81,093 on our investments. While this is very exciting news, we know investments can go up and down. The committee has met quarterly to monitor our investments.

The Trust Fund committee has been busy this past year. One of our projects was looking to consolidate the three Youth Trust Funds we had. These trust funds seemed to overlap in their mission in many regards so we wanted to consolidate them into one trust fund. We were able to contact the closest living relative of each family that started the trusts. Each family agreed to consolidate into one account. The new Trust Fund is now called **First Lutheran Church Youth Ministries Fund**.

The committee also worked hard at developing the resolution before the congregation today. We started out by discussing ways to be good stewards with the monies the church has received from the sale of the two parsonages. We understand the congregation wanted to use the money for church repairs. We also felt that this money was not going to be able to cover the repairs needed over time. The money is listed as a Memorial within the Trust Fund and it could be requested in its entirety by the church council.

We looked for ways to still be able to use these monies as the congregation intended but also preserve it to some degree. One phrase I recall hearing was a “Nest Egg”. The person indicated that there has been talk for many years that FLC needs to set aside a nest egg for building repairs. We feel that this resolution does just that. It gives us a “nest egg” of \$150,000 to build upon. It also gives us money to spend over time like other trust funds. The last thing it does is challenge the congregation to match money used from the trust fund. We feel that this will not only help the congregation get behind projects in the future, but it will also help stretch out the dollars we spend.

For gifts back to the church, the Council requested \$3,059.29 from the Trust Fund this past year. Overall, the committee feels very good about the position of the Trust Fund at this time.

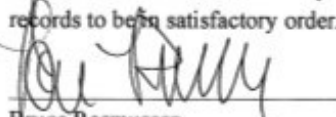
